Des Moines Ballroom, 3rd Floor

The Insurrection Clause, Section 3 of the Fourteenth Amendment, was enacted after the Civil War to bar Confederates from regaining power, undermining Reconstruction and otherwise interfering with the full citizenship rights of African Americans. The Insurrection Clause disqualifies most federal and state officers who "have engaged insurrection or rebellion" against the United States or "given aid or comfort to enemies" of the United States from holding any federal or state office. Recent court decisions have significantly weakened the Insurrection Clause rendering it ineffective to protect the Rule of Law and attacks upon democracy. Can it be resurrected? This program will discuss the historical basis for the Insurrection Clause, court decisions undermining its effectiveness, and a pathway to restoring its important protections.

Impact of the 92%: Black Women Embracing Our Resilience and Redefining Our Purpose (*Presented by the NBA's Women Lawyers Division*) Iowa Ballroom, 2nd Floor

This discussion explores the vital role of Black women lawyers in advancing equity, justice, and systemic change in the years to come. The conversation is anchored in the pivotal statistic that 92% of Black women voters voted a particular way in the 2024 presidential election, reflecting a deep alignment with justice and equity-driven initiatives. With the nation now facing a significant rollback of these initiatives, there are significant challenges ahead and repositioning required.

The panel discussion will examine the unique and impactful role Black women lawyers have in developing and implementing transformative policies having longstanding implications. The panelists will discuss upcoming policy changes and potential shifting jurisprudence forthcoming that will likely impact marginalized communities disproportionately. The panelists will also discuss ways in which we can position ourselves, including through philanthropy, mental health and wellness, and tapping into our internal resilience, as Black women.
